EXECUTIVE ORDER

BY THE GOVERNOR:

WHEREAS: Georgia's medical providers possess a wealth of knowledge and experience delivering high quality healthcare using state-of-the-art technology while maintaining fiscal responsibility; and

WHEREAS: The state needs a working partnership with healthcare providers to ensure that we take the most responsible steps possible as we continue to improve healthcare in Georgia.

NOW, THEREFORE, BY THE POWER VESTED IN ME AS THE GOVERNOR OF THE STATE OF GEORGIA, IT IS HEREBY

ORDERED: That the Georgia Physicians Partnership ("the Partnership") is created to advise the Department of Community Health as it administers state healthcare programs and works towards its healthcare policy priorities.

ORDERED: That the Partnership will consist of at least ten medical providers recognized as leaders in their fields, and representative of the entire state, who shall serve at the pleasure of the Governor.

ORDERED: That members of the Partnership shall serve without compensation but shall be entitled to receive reimbursement for actual and necessary expenses incurred in the performance of their duties for the Partnership in accordance with the state's Statewide Travel Regulations.
