EXECUTIVE ORDER

BY THE GOVERNOR:

WHEREAS: Fort McPherson is being closed pursuant to the federal government's Defense

Base Closure and Realignment Act of 1990; and

WHEREAS: The planned closing of Fort McPherson has provided a redevelopment

opportunity for the Cities of East Point and Atlanta, Fulton County, and for the

State of Georgia; and

WHEREAS: The McPherson Planning Local Redevelopment Authority has adopted a

Redevelopment Plan and Homeless Assistance Submission for Fort McPherson;

and

WHEREAS: In order to receive portions of Fort McPherson as an Economic Development

Conveyance, as defined in 32 CFR 174.9(a), and to fulfill other obligations under federal base closure law, an Implementation Local Redevelopment Authority must be established. The McPherson Implementing Local Redevelopment Authority Act, HB 817, was signed into law on May 14, 2008, establishing the

implementing authority; and

WHEREAS: In accordance with Section 31 of the McPherson Implementing Local

Redevelopment Authority Act, an Executive Order finding that a need for the authority exists must be issued before the members can be appointed and any

action can be taken by the Implementing Authority; and

WHEREAS: The need for ordering the initiation of the McPherson Implementing Local

Redevelopment Authority exists with regard to the closure and realignment of

Fort McPherson.

Now, therefore, pursuant to the authority vested in me as

GOVERNOR OF THE STATE OF GEORGIA, IT IS HEREBY

ORDERED: That the McPherson Implementation Local Redevelopment Authority commence

the undertakings as prescribed by the McPherson Local Implementation

Redevelopment Authority Act.

IT IS FURTHER

ORDERED:

That the members of the McPherson Implementing Local Redevelopment Authority to be appointed by the Governor from a list of nominees supplied in accordance with the provisions of the McPherson Implementing Local Redevelopment Authority Act shall be as follows:

ORDERED:

That the Chairperson of the McPherson Implementing Local Redevelopment Authority shall be Felker W. Ward, Jr. The members of the McPherson Implementing Local Redevelopment Authority shall thereafter select a vice-chairperson and other officers in accordance with the McPherson Implementing Local Redevelopment Authority Act in order to accomplish the goals set forth therein.
