- 1. As of FY2009, the local sales tax distribution changed to reflect perpetual daily distributions for the current month based upon total sales tax collections.
- 2. On December 7th, 2009 DOR issued a Sales tax pro-rata distribution for \$24.7M authorized by H.B 181. Of the \$24.7M total, \$13.8M was for May2009-July2009 payments and \$10.9M was issued for payments made prior to January 1,2008. DOR will make quarterly pro-rata sales tax distributions until December 31,2011

- 3. The Motor Vehicle Division began collecting Auto Sales Tax funds in January 2006. An adjustment was made to reclassify Sales Tax collections from Motor Vehicle to Other Fees and Sales, to reflect the transaction in December FY 2010. This revenue is then reclassified to Sales Tax next month.
- 4. Other Fees and Sales include taxes and fees that have been deposited in the bank, but the returns have not been processed. The undistributed amounts, as processed, are reclassified to the proper accounts. It also includes unclaimed property collections.
